The Medical Assessment and Rating Board has received online application (Part-1) seeking permission for student intake in Under Graduate (BHMS) course with student intake of 100 seats in UG (BHMS) course & 42 seats in PG [MD (Hom)] for the academic year 2022-23.

2. As per provision of NCH Act, 2020 Medical Assessment and Rating Board for Homoeopathy (MA&RBH) has been constituted with the mandate to grant permission for student intake to the existing and new medical institution of Homoeopathy. Accordingly, it is to inform that Part-1 Performa and all the relevant documents submitted by your college were examined as per the existing regulations.

- Dr. Rahul Sharad Kulkarni (Professor, Pharmacy) Dr. Anagha Pravin Beedkar (Reader, Pediatrics) and Dr. Yogesh Bharatal Jaiswal (Reader, Psychiatry): Previous experience certificates are not provided.

B. **MISCELLANEOUS:**

- TCG facility is not available.
- Alcohol License renewal is not available.
- Form-16 of only 05 staff is provided.
- Website functional but IPD/OPD data is not updated as checked on 08/11/2022

5. After considering the provisions of NCH Act, 2020 the conditional permission of the Medical Assessment and Rating Board for continuing admission is granted to Dakshin Kesari Muni Mishrilalji Homoeopathic Medical College, Shri Guru Ganesh Nagar, Behind Bi-Bi-Ka Maqbara, Maharashtra, Aurangabad-431004 for admission of 100 students in undergraduate course (BHMS) and 42 seats for postgraduate course MD (Hom.) in 07 subjects namely, Practice of Medicine, Organon of Medicine, Materia Medica, Repertory, Pharmacy, Pediatrics and Psychiatry for 06 seats each for the academic year 2022-23.


6. The College Principal is directed to fulfill all deficiencies within a period of 3 months and an undertaking shall be submitted in this regard from the Controlling Authority of the College within a period of 07 days from issue of this letter of conditional permission.

7. As per section no. 43 of the NCH Act 2020, vide letter no. Y-11011/4/2022-EP-III dated 14/10/2021, Central Govt. has taken a policy decision that all admission shall be through NEET only with qualifying marks 50 percentile. All admissions in Under Graduate (BHMS) course shall be through 'National Eligibility Entrance Test (NEET)' and all admissions in Post Graduate course shall be through 'All India Ayush Post Graduate Entrance Test (AIAPGET)' only. Any admissions carried out other than NEET/AIAPGET qualified students will not be approved by the Medical Assessment and Rating Board for Homoeopathy as per rules and the penalty as decided will be imposed.

8. The counseling for seats under All India quota shall be conducted by respective counseling Authority of State/ UT Government as designated by the Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counseling Authority of that State / UT. 100% Under Graduate & Post Graduate seats of the permitted intake capacity shall be treated as all India quota for Deemed University as they are All India in nature. The Counseling of seats under All India Quota shall be conducted by Central Government.


9. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India quota or the student admitted there under. The category wise list of students admitted may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed.


